This bonus is for new and veteran Promoters—qualify at the rank of 4K, 12K, 40K, 80K or 200K during the time-frame for the first-time and get the VIP Rank Advancement Bonus. Current 200Ks are eligible for the Premium Advancement Bonus.

You must maintain the bonus rank and PPA requirements and remain Qualified & Active each month throughout the payout period to continue to receive bonus payments; you will not receive any bonus payments for months where qualification is not met. If you qualify for the bonus at multiple ranks and do not maintain the highest rank, you will still receive bonus payments for any lower ranks that you are qualified for.

Bonuses will be made up of equal monthly payments, beginning the month after the qualification is achieved. If a higher qualification is met, then the difference will be added to your payments. Example: You qualify for the 12K VIP bonus in February, you will begin receiving your payments for \$12,000 on February's monthly commission check. In March, you qualify for the 40K VIP bonus, you will begin receiving further payments on your March monthly commission check to make up the difference between \$12,000 and \$40,000 so that you will be paid a total of \$40,000 if you remain qualified through the entire payout period.

As always, Promoters must remain in good standing with Le-Vel's policies & procedures to qualify for and earn bonus payments. Bonus buying will be strictly enforced. This bonus is not available in Mexico.
